## IN THE NEWS

### Testing Center Gets New Leadership

The Office of Distance Learning is pleased to announce that Dr. Joseph ("Joe") Clark, Associate Director at the Office of Distance Learning, will be taking over leadership of the Testing Center. Clark has a long tenure at FSU that includes test development and administration; instructional design; and consulting in pedagogy, instructional technology, and online learning. As a faculty member, he's served on and chaired a number of committees during his nearly 20 years at FSU. Clark currently represents FSU on the State University System of Florida Board of Governors Distance Learning Subcommittee on Quality.

A key goal of ODL's strategic plan is to ensure that the Testing Center will be known as a model for academic integrity and student success. One of the first steps in that process is to pursue certification with the National College Testing Association, a highly regarded source of standards and community for testing professionals. We're also re-examining our internal and external communications for greater efficiency and clarity, and to improve the test-scheduling and test-taking experience for our students.



"The Testing Center staff are a committed and experienced group of professionals and I'm proud to work with them to serve the FSU community," said Clark. "We're looking forward to making the center an even better place to take tests while maintaining critical standards that maintain the security and

validity of the testing process."

Over the last year, the Testing Center has made a number of improvements. We hired a Customer Service Manager who has implemented customer service training for our front-line staff. We added a second scanning drop box with extended hours, and we upgraded the network and electrical infrastructure in Miller Hall, enabling us to provide an overflow facility to accommodate additional students during high-volume weeks of testing.

More improvements are planned for the future. We're currently replacing our testing stations with newer, more robust hardware, and we will improve our exam scheduling and registration process to better serve the needs of our instructors and students.

## Spring Course Evaluation Info on the Way

Instructors and department administrators should be on the lookout for email reminders the week of March 5 to take the necessary steps to ensure a smooth course evaluation process this semester. These emails will provide all the necessary information to conduct evaluations and will include tutorials to guide users through the process.

### Important Dates for the Spring 2019 Semester

**Tuesday, March 5:** Administrative window opens

- Instructors and administrators should check enrollment information and add any custom questions in EvaluationKIT at this time
- Paper packets may be ordered at this time

**Wednesday, April 2:** Last day to order paper packets

**Friday, April 12:** Evaluation window opens

- Students may begin evaluating courses and instructors

**Friday, April 26:** Evaluation window closes

- Last day to administer evaluations

**Wednesday, May 1:** Deadline to return paper packets

**Friday, May 10:** Reports are released

Student feedback is an essential part of improving FSU courses and programs, so we ask that instructors encourage students to complete evaluations for all their courses. ## Online Evaluation Response Rates on Rise

### EvaluationKIT

Student Feedback Made Simple®



Response rates for online course evaluations are on the rise for online graduate programs, according to data pulled from our online course evaluation system EvaluationKIT.

The College of Business posted a double-digit increase in course evaluation response rates over the past year. In 2018, the response rate for the online graduate MBA program was 25.7%. That figure increased to 77.2% in 2019, for a jump of over 50%. Other programs also showed an upsurge. Programs that participated in a 2017 pilot of EvaluationKIT, such as Computer Information Technology, saw an increase in evaluation response rates during that time. After this initial increase, EvaluationKIT participants maintained elevated response rates in respect to historical averages.

Mike Straszewski, Scanning and Evaluations Supervisor, attributes the higher response rate to the implementation of EvaluationKIT, which streamlines the student feedback process through Canvas. ODL piloted EvaluationKIT in Summer 2017 and implemented automatic online evaluations in Summer 2018. “Through this new process, instructors are automatically in compliance with the governing evaluation policy and are able to insert their own questions tailored to the nature of the course,” said Straszewski.

The response rate data were compiled as part of the *U.S. News & World Report* Best Online Program rankings. Each year, ODL gathers data for submission to the annual rankings. Data included in the 2019 response rates reflect Summer 2017, Fall 2017, and Spring 2018 enrollments.

## Online Grad Programs Rank in Top 20

Four of Florida State University’s online graduate programs ranked in the Top 20 nationally, according to [\*U.S. News & World Report’s 2019 Best Online Programs\*](#).



The College of Criminology and Criminal Justice’s online graduate program continues to rank among the best in the nation at No. 6, jumping one spot from the previous year. The college offers a master’s degree in [criminal justice studies](#).

“We are excited that our college’s online graduate program continues to be recognized among the very best in the nation,” said Thomas Blomberg, Dean of the College of Criminology and Criminal Justice and Sheldon L. Messinger Professor of Criminology. “We also remain extremely pleased that, through this program, we are able to offer a diverse group of students from across the country the same high-quality education and instruction as our on-campus students.”

The College of Business's non-MBA online graduate program placed No. 12 in the nation. Students interested in this field can pursue master of science degrees in [management information systems](#) and [risk management and insurance](#). The college's online [MBA program](#) checked in at No. 21.

The College of Education's online graduate program held steady in the No. 13 position. The college offers degrees in [curriculum and instruction](#), [educational leadership](#), [instructional systems and learning technologies](#), and [learning and cognition](#).

The College of Communication and Information's online graduate program in [information technology](#) was ranked No. 14 in the category of computer information technology. The master of science degree is offered by the college's School of Information.

The methodology for ranking online programs included five general categories: student engagement, faculty credentials and training, student services and technology, peer reputation, and admissions selectivity.

## Using Course Dates in Canvas

Have you ever looked at your Canvas course settings and wondered why your course dates are empty?

Term:

Changing course dates may override term availability settings and placement in the Courses page and Dashboard. Please confirm term dates before modifying course dates.

Students can only participate in the course between these dates

When selected, the course is in a read-only state outside these dates.

Restrict students from viewing this course before start date

When selected, the course is inaccessible outside course dates. If the course dates are blank, these start and end dates apply to the term dates.

All Canvas courses are assigned to a particular term, such as Spring 2019, which determines the default dates for that term during which students may submit assignments and complete other activities in your course site. The start and end date fields in your course settings allow you to override the default term dates, as needed, for the term that your course has been assigned. If you would like to allow a student extra time to submit the final paper before final grades are due, you can override the default term dates. However, we do not recommend extending the course end date unless absolutely necessary. Keep in mind that extending the course end date too far can cause problems, including:

- Keeping the course on your and your students' Dashboards long after the course has ended. If you teach a similar course from semester to semester, this may make it more difficult to locate your current courses.
- Potentially making it possible for students to accidentally re-submit assignments or post to discussion items.
- Students receiving notifications about the course after it has ended.

If you have a student who needs to [finish an incomplete](#), [contact ODL Technical Support](#) for assistance so that the course remains active for only that particular student and not the entire class.

If you want your students to have access to the course material after the course is over, you don't need to extend the end date. Students automatically default to having read-only course access for up to a year after the course ends. For more information, learn [how user enrollments and course access work in Canvas](#).

## Release Notes

The January production release notes from Canvas describe updated features and bug fixes. With the new Preview feature in Commons, instructors can review resource content before importing it into their course. ## TOOL TIME

### Gradebook Tips

While it may seem early to be discussing grades, finals will be here before you know it. To help you keep your Canvas gradebook tidy and user friendly for both you and your students, we've put together the following tips.

- Make sure the [Canvas course Grading Scheme](#) in your course settings matches the scheme you provide in your course syllabus.
- Ensure that you un-mute assignments once you've finished grading them—students can't see their grade and any feedback you've given them while the Gradebook column is muted.
- Be sure to grade as you go and leave no grade cell empty.
  - Want to efficiently assign zeroes to only unsubmitted assignments after the assignment due date has passed? Use the [Set Default Grade feature](#). Though leaving a dash in the grade cell will automatically penalize the student for not completing the assignment, it often results in confusion for students because [they may not be seeing what you see](#).
  - For an excused or optional assignment: Make sure to mark "EX" in the student's grade cell for anyone who didn't submit the assignment. Leaving a dash in the grade cell will automatically penalize the student.
- Want to [drop your students' lowest quiz score](#)? You can do it automatically in Canvas, but make sure that all the quizzes are in their own assignment group that contains no "ungraded" items.
- If you're considering offering extra credit, [make sure that it will be factored into your students' final grades correctly](#).
- Don't like working in Canvas? Or, trying to do a complex calculation? You can [download your gradebook](#), complete your edits in Excel, and then [upload the changes](#).

### New Gradebook

Although the above tips apply to both the old and new Canvas gradebooks, we recommend [opting in to the New Gradebook](#) to get more familiar with it before it becomes the default gradebook beginning Summer 2019. [New Gradebook features](#) include simplified navigation, drag-and-drop organization, late and missing submission policies, and color coding.
